If second payment is not received by April 15, 2023, your first payment will be refunded minus a \$50.00 service fee. Please let us know if these terms are acceptable. We must be firm with these dates. No refunds after 5/15/23

## Rules and Regulations

- Speed limit is **5 MPH**, please advise your guests.
- **NO** running or jumping on docks
- All boats must be secured to docks in an acceptable manner:
  - All dock lines must be of good quality marine rope of a proper size to adequately hold the boat
  - The use of clothesline or ski rope will not be permitted
  - Lines shall be arranged in a manner so as not to cause a safety hazard on docks
  - All lines will have enough slack to allow boat some freedom of movement without putting strain on docks
- **AIR CONDITIONERS** are allowed to run off dockside power **ONLY** when you are present.
- **NO MECHANICAL WORK OF ANY KIND** is allowed on any boat at docks or on marina property due to insurance liability and EnCon Regulations
- No bottom washing, scraping, or painting on marina property without approval from Mohawk Valley Marine owner
- All boaters will be careful not to cause a wake when approaching or leaving marina area
- You are responsible for your own wake and will be held liable for any damages caused by your wake
- All hardware added to docks must be approved by Mohawk Valley Marine owner
- All power lines from receptacles to boats will be of adequate size and will be arranged on docks in a way that will not cause safety hazards
- **All pets must be leashed! Clean up after your pet-- if pet becomes an issue, it will be asked to be left home**
- Subletting docks is not permitted
- **NO open fires!** Gas or charcoal grills are permitted. The only fires permitted are in front of hanger in the pit and in the fireplace near the club house
- Mohawk Valley Marine is not responsible for personal items left unattended on property or in boats
- Docks and picnic area must be kept uncluttered and neat at all times
- All boaters are asked to report any accidents or damages to Mohawk Valley Marine owner-- this includes docks, grounds, wakes, gas/oil spills, etc
- All boaters are responsible for their guests' behavior on marina property
- **NO** underage consumption of alcohol will be permitted on marina property
- Children age 12 and under must have proper adult supervision and proper fitting vest while on docks
- We have the right to board your boat at anytime if there is a threatening situation!
- **We will not be responsible for any damage or loss of trailers left in our yard**

We appreciate you abiding by the above rules. Please advise your guests of our regulations. Any continued disregard for these rules will be grounds for expulsion with no refund. We would be happy to help you if you have any questions. Happy Boating!
