We advise the owner(s) to remove all non-attached items from the boats, especially electronics and other valuable items.

The failure of the owner to remove said vehicle from the premises of MOHAWK VALLEY MARINE, INC., by June 1<sup>st</sup>, following the date thereof shall, in the absence of written notice by MOHAWK VALLEY MARINE INC. to the owner, be deemed a renewal hereof for twelve (12) months at the summer storage rate of \$100.00 per month and on the same conditions.
